

## Superintendent (MEP) – Critical Facilities & Infrastructure

### **Summary**

The construction Superintendent coordinates all site construction activities and supervises all field personnel as required to successfully completing the project on schedule. This includes maintaining the highest quality, supervising all trade and field personnel, while administering good construction safety practices with all on-site activities. Skyline Construction is looking for a Superintendent Mechanical / Electrical / Plumbing (MEP) to work in its Critical Facilities & infrastructure Group. Requirements for the project include, but are not limited to, the following:

### **Essential Duties and Responsibilities:**

- Manage all field activities.
- Ensure that subcontract's staffing levels are consistent with that required to maintain the project schedule.
- Ensure that work is being done in compliance with plans and specifications.
- Address any subcontractor design questions via the RFI process.
- Maintain daily job site work records.
- Ensure overall job quality, safety and cleanliness.
- Ensure all jobs are finalized and closed out promptly, especially with regards to Punch Lists
- Work nights, weekends, holidays, etc. as required by the project.
- Coordinates and supervises all construction activities.
- Directs all field personnel to achieve completion of the project on schedule, with quality workmanship that conforms to original plans and specifications.
- Maintains construction schedule, identifies and solves problems.
- Orders materials and schedules inspections as necessary throughout the process.
- Maintains positive relationships with customers, contractors, suppliers and other employees.
- Supervises completion of a final punch list.
- Maintains up to date job site daily's and weekly tailgate meetings.
- Promotes job site safety, encourages safe work practices and rectifies job site hazards immediately.
- Ensures all company employees and contractors are adhering to the company safety policy.
- Maintains an organized job site, including the construction office.

### **Knowledge, Skills and Abilities**

- Experience in the implementation of Data Centers, Server Rooms, Telecommunication Switch Sites, etc.
- Candidate shall have experience in scheduling and shall be able to schedule complex MEP and Data Center projects using scheduling software.
- Strong interpersonal skills.

### **Experience and Education**

Minimum 8-10 years Superintendent experience in the implementation of Critical Facilities/ Data Centers and building infrastructure. Graduation from an accredited four-year college or university preferred or related experience. LEED accreditation preferred.

### **Physical Demands**

The employee must be able to utilize a computer to perform data entry, word processing, and spreadsheet operations. Employee must be able to communicate effectively with management, staff, and outside entities. The employee will be required to safely walk, stand, reach with hands and arms, climb, balance, stoop, kneel, crouch, crawl, see and hear. ### **Work Environment**

While performing the duties of this job, the employee may be exposed to outside weather conditions at job sites, including wet and/or humid conditions, cold, and heat. For renovation work, hazardous material or conditions may be present in the existing building. The noise level at these sites may be unusually loud at times. Job sites are typically dusty.
